- Councillor Bentley reported that work on the footpath at Stunts Green will be carried out in the near future.
- The Consultation on the Waste and Minerals Plan may has identified the following sites for a Waste Transfer Station; former Shep Plastics factory site on A22 and the Pumping Station at Amberstone.
- He noted that WDC has indicated that more houses will be built in the Wealden District and the timescale has been extended to 2037.
- Sussex Police are arranging a meeting with young people in the county to look at the impact of policing on young people.
- The Pevensey Levels Drainage Board will increase the amount of water allowed on to the Levels

Mr W. Gower, the Chairman of the Drainage Board that this may be a long term plan but that all water run-off on to the levels will be strictly monitored.

- East Sussex County Councillor L. Keeley reported his concerns that the clean water supplied from SE Water is under stress.
- He is concerned that the infrastructure of sewage, water, schools etc is not been put in place quickly enough to cope with the expected increase in housing.
